THE DEFINITIVE MAP & STATEMENT OF PUBLIC RIGHTS OF WAY
FOR GLOUCESTERSHIRE
ADDITIONAL PUBLIC FOOTPATH AND SEPARATE RESTRICTED BYWAY AT
GUNHOUSE LANE, BOWBRIDGE, BRIMSCOMBE & THRUPP PARISH
MODIFICATION ORDER 2022

The above Order made on 20 October 2022, if confirmed as made, will modify the Definitive Map and Statement for the area by adding to them the following length of public footpath and separate restricted byway at Gunhouse Lane, Bowbridge, Brimscombe & Thrupp Parish:

A length of restricted byway known as Gunhouse Lane in Bowbridge, Brimscombe & Thrupp Parish, Gloucestershire which commences at a Point marked A on the Order Plan annexed hereto ("the Plan") at Ordnance Survey Grid Reference ("OSGR") SO 8585/ 0427 at its junction with London Road (publicly maintainable highway A419) and runs in a generally south easterly direction for approximately 435 metres and then in a generally southerly direction for a further 43 metres to a point marked B on the Plan at OSGR SO8617/ 0393 at its junction with Thrupp Lane (publicly maintainable highway 41327) and shown by a broken black line with small arrowheads on the said plan and having a varying width of 1.4 - 3 metres between points A-B.

A length of public footpath known as Gunhouse Lane in Bowbridge, Brimscombe & Thrupp Parish, Gloucestershire which commences at a Point marked C on the said plan at "OSGR" SO 8590/ 0424 at its junction with the said Restricted Byway, also known as Gunhouse Lane and runs in a generally north easterly direction for approximately 84 metres to a point marked D on the Plan at OSGR SO8597/ 0430 at its junction with Public Footpath ZST57 and shown by a broken black line on the said map and having a varying width of 2 - 3 metres between points C-D.

Please note that any existing private vehicular access rights are unaffected.

If no such representations or objections are duly made, or if any so made are withdrawn, the Gloucestershire County Council instead of submitting the order to the Secretary of State for the Environment, Food and Rural Affairs may confirm the order. If the order is submitted to the Secretary of State for the Environment, Food and Rural Affairs for confirmation, any representations or objections which have been duly made and not withdrawn will be sent with it.
